THE BENEFITS INCLUDE IMPROVED WORKPLACE SAFETY AND PREPAREDNESS, THE ABILITY TO RESPOND QUICKLY AND EFFECTIVELY TO EMERGENCIES SUCH AS FIRES OR EVACUATIONS, REDUCED RISK TO PEOPLE AND PROPERTY, AND INCREASED CONFIDENCE FOR INDIVIDUALS TASKED WITH SUPPORTING EMERGENCY CONTROL OPERATIONS.

Course Description

PUAFER005 Operate as Part of an Emergency Control Organisation

This unit of competency involves the skills and knowledge required to work within the command, control and coordination structure of an Emergency Control Organisation (ECO). An ECO's priority is the safety of facility occupants and visitors during an emergency which means ECO members are responsible for pre-emergency, emergency and post emergency actions. It includes undertake pre-emergency planning, taking appropriate actions in an emergency and assisting with post emergency activities.

The unit has been developed to cover the facilities as specified in Australian Standard (AS) 3745 and AS4083. For this unit, as covered by AS3745 and/or AS4083, occupants are people attending a facility on a permanent or temporary basis such as an employee, contractor, student or resident, but not a visitor or patient and a facility is a building, structure or workplace that is, or may be, occupied by people (occupants).

All aspects of the unit must be undertaken in accordance with legislative requirements, organisational policies and procedures and accepted safe practices. It applies to members of an ECO who are floor or area wardens and/or wardens or deputy wardens.

No licensing, legislative or certification requirements apply to this unit at the time of publication.

CPPFES2005 Demonstrate First Attack Firefighting Equipment

This unit of competency specifies the skills and knowledge required to demonstrate first attack firefighting equipment. It includes demonstrating and explaining to clients how to correctly and safely use portable fire extinguishers, fire hose reels and fire blankets in emergency situations.

The unit is suitable for those with basic skills and knowledge undertaking routine work tasks under the direction of more experienced workers.

Licensing, legislative, regulatory or certification requirements apply to this unit of competency in some states and territories. For further information, check with the relevant regulatory authority.

Target Cohort / Entry Requirements

This course is intended for:

- Employees nominated as Fire Wardens or part of an Emergency Control Organisation (ECO) within a workplace

- Staff across industries such as offices, construction, warehouses, retail, healthcare, and industrial sites requiring emergency response training
- Supervisors, team leaders, and managers responsible for coordinating evacuations and ensuring workplace safety
- Facility and building management personnel overseeing fire safety systems and emergency procedures
- Workplace health and safety (WHS) representatives involved in emergency planning and compliance
- Construction and site workers operating in environments with elevated fire risks
- New or existing employees requiring combined fire warden and extinguisher training to meet organisational or legislative requirements
- Personnel expected to respond to small fires and assist with evacuation procedures as part of workplace emergency preparedness

Entry requirements may include:

- Language, literacy, numeracy and digital skills (LLND test may apply)
- Minimum age of 18 (If under 18 parental consent is required).
- Physical requirements - A participant must be in good health and medically fit for work.
- All students participating in VET qualifications are required to have a Unique Student Identifier (USI).
- The RTO will provide the prospective student with a Course Suitability Checklist that will help the student and the Trainer / Assessor if the course is relevant and applicable to students' needs.
- The RTO will provide constructive and honest feedback to the prospective student if it is decided that the VET student does not yet have the LLN+D skills or meet the entry requirements to cope with the rigor of the training and assessment material and process.

Selection Criteria

Learners should demonstrate:

- Reading and writing ability in varied contexts
- Oral communication and comprehension skills
- Basic numeracy and mathematical problem-solving
